PURPOSE AND LEGAL BASIS OF PROCESSING

We process your personal data as follows:

3. We process the data that you voluntarily provide and that is necessary for the administration of the EUSALP Energy Award.

CRITERIA FOR DETERMINING THE STORAGE PERIOD

Booking data and enrolments: Your data will be stored for 10 years in accordance with the provisions of the CC.

Publication of website data: Your personal data will be published until cancellation. Details on the deletion strategy are available on request.

YOUR RIGHTS:

Every data subject has the right **to withdraw consent**

once given in accordance with Article 7(3) GDPR, the right of **access** in accordance with Article 15 GDPR, the right to **rectification** in accordance with Article 16 GDPR, the right to **erasure** in accordance with Article 17 GDPR, the right to **restriction of processing** in accordance with Article 18 GDPR, the right to **object** in accordance with Article 21 GDPR and the right to **data portability** in accordance with Article 20 GDPR. You also have the **right to lodge a complaint** with a data protection supervisory authority (Article 77 GDPR).
